### Advanced PMU Techniques 24 contact hours

Prerequisite: Licensed Esthetician or Cosmetologist.

132 hour Permanent Makeup Certification, at least 6 months of PMU experience and basic knowledge and use of rotary machine device.

Occupational Objective: This course teaches advanced techniques of permanent cosmetics as it pertains to eyebrows, eyeliner and lips. Students will learn the newest tattooing trends and techniques in eyebrows, eyeliner and lips using manual hand tools and digital or rotary devices.

Available online at Tri-County Health Department, Colorado Occupational Objective: To educate the Licensed Cosmetologist / Esthetician (for Colorado technicians, check your own state requirements) in the Art of Permanent Cosmetics from a cosmetic viewpoint. Students will be educated in the aspects of sanitation and safety of Permanent Cosmetics. Students are taught machine and manual techniques with main focus on machine application. ### POLICY ON OTHER FEES CHARGED

1.Cancellation Fee/ Course Change Fee - \$150

4.Document or paperwork copy fees for students - \$ 0.21 per page /\$18.00 per hour with minimum of one hour charge. A reasonable amount of time must be allowed to complete the request.

5. Any returned checks for insufficient funds or closed account written to the school for tuition or services will be charged a fee of \$30.

6.Any collection charges or legal fees that may be incurred as a result of returned checks or monies will be the responsibility of the student.

### **Class Schedule**

Class schedules are determined by student request and enrollment. Class Schedules are flexible & will be determined based on student enrollment. AAB offers advanced classes throughout the year that are posted on our website <u>www.academyofadvancedbeauty.net</u> and Instagram (@academyofadvancedbeauty) as scheduled. Students are given up to 1 year from date of enrollment to complete the Nail Program. Students also have up to eight weeks from date of enrollment to complete the FT Permanent Makeup class.

When an unexpected closure occurs due to extraordinary conditions such as inclement weather, students will be notified as soon as possible by phone and email. Classes are not held on the following holidays:

### **Entrance Requirements**

- 1. Interview with School Director
- 2. Complete and sign Enrollment Agreement/Pay any Fees/Deposit/Kit costs if applicable.
- 3. Affidavit of US Citizenship Eligibility.
- 4. Proof of Age (Driver's License, State I.D., Birth Certificate, or Passport).

5. Advanced class students with prerequisite requirements listing licensure or certificates will be required to provide copy of their valid Esthetician or Cosmetologist license or other certifications.

6. Understand the English language: read, write and speak. All programs taught in English.

### Enrollment

Prospective students may enroll anytime, provided there is availability in the class. Late enrollments will be accepted only one week into the course, depending on length of the course.

### **Postponement of Start Date**

Postponement of a starting date, whether at the request of the school or the student, requires a written agreement signed by the student and the school. The agreement must set forth:

- a. Whether the postponement is for the convenience of the school or the student, and;
- b. A deadline for the new start date, beyond which the start date will not be postponed.

If the course is not commenced, or the student fails to attend by the new start date set forth in the agreement, the student will be entitled to an appropriate refund of prepaid tuition and fees within 30 days of the deadline of the new start date set forth in the agreement, determined in accordance with the school's refund policy and all applicable laws and rules concerning the Private Occupational Education Act of 1981.

### **Placement Assistance**

The Academy of Advanced Beauty does not offer employment assistance to students. Current law prohibits any school from guaranteeing job placement as an inducement to enroll students.

### **Attendance Requirements**

**1-3 Day Classes:** Students are expected to arrive on time for class with proper materials. These are advanced, fast paced classes and the content covered requires an attendance rate of 100%. Students who are unable to continue classes for medical reasons or severe personal problems and are unable to return to class will be asked for proper documentation to substantiate a student's withdrawal.

**Permanent Makeup:** Students are expected to arrive on time for class with proper materials. Students are expected to attend an overall attendance rate of at least 85% is required. Instructors may request your withdrawal from a course or program if absences or tardiness exceed 85%. Students who are unable to continue classes for medical reasons or severe personal problems will be required to take a leave of absence until they are able to return to class. Proper documentation will be required to substantiate a student's withdrawal. If they miss scheduled hours they will have the opportunity to make up hours. It is the responsibility of the student to arrange with the Instructor time to make up any missed hours within four (4) weeks of the missed scheduled hours. Certificate of completion will not be issued until missed hours are completed. Should the student go over the completion date, there will be extra instructional charges of \$75 per hour for missed scheduled hours.

**Nail Tech Program:** Students are expected to attend all mandatory core classes. If they miss class they will have one (1) more opportunity to take that class in that calendar year. If they fail to take the second offered class then they will incur fees for taking the class outside the calendar year. Fees are explained below. This program is a student maintained program. The student designs their own schedule for attendance around their personal schedule. Students may be at the school any time there is an instructor there. Students are encouraged to complete the full program in six (6) months but have up to twelve (12) for completion.

Should the student go over the completion date, there will be extra instructional charges of \$5 per clock hour until graduation. Students have one complete calendar year from the date of enrollment to complete their 600 hours at \$10/clock hour. After the calendar year the clock hour will increase to \$15/ clock hour. If a student fails to earn credit on a grade sheet on a core class then the student must make up the credit at the end of their program. This may result in additional charges of \$15/ per clock hour.

### **Academic Progress Policy**

#### Stand Alone 1-3 Day Classes

Students must maintain a satisfactory standing in the class. Qualitative factors will be evaluated by daily checklists of skills met and practical hands evaluation. Granting of clock hours will only be awarded to students maintaining 100% attendance, progress reports are given to students daily. Students meeting requirements at the end of each day will be considered making Satisfactory Progress. In order for a student to be considered making Satisfactory Progress, the student must meet both attendance and academic minimum requirements.

#### **Permanent Makeup**

Students must maintain a satisfactory standing in the class. Those who do not will be placed on probation. Determined by program length and what week student is within the program not to exceed 15 days. During the probation period students must raise their grade average to passing or higher. The student may be terminated if progress is not satisfactory at the end of the probationary period. Termination shall be at the school Director's discretion. The Director has final authority and shall notify the student of the final decision. Qualitative factors will be evaluated by tests, worksheets and practical hands on procedures. If a students grade on a practical sheet is below 75%, then he/she must make-up the grade sheet. The second grade earned will be the grade of record for the student's GPA. Granting of clock hours will only be awarded to students maintaining a 75% grade point average and an 85% in attendance, progress reports are given to students weekly. Students meeting requirements at the end of each period will be considered making Satisfactory Progress. In order for a student to be considered making Satisfactory Progress, the student must meet both attendance and academic minimum requirements.

#### Nail Tech Program

Students must maintain a satisfactory standing in the class. Those who do not will be placed on probation. Determined by program length and what week student is within the program not to exceed 30 days. During the probation period students must raise their grade average to passing or higher. The student may be terminated if progress is not satisfactory at the end of the probationary period. Termination shall be at the school Director's discretion. The Director has final authority and shall notify the student of the final decision. Qualitative factors will be evaluated by test, projects and practical worksheets. If a students grade on a practical sheet is below 75%, then he/she must make-up the grade sheet. The second grade earned will be the grade of record for the student's GPA. Granting of clock hours will only be awarded to students maintaining a 75% grade point average and an 85% in attendance, progress reports are given to students monthly. Students meeting requirements at the end of each payment period will be considered making Satisfactory Progress. In order for a student to be considered making Satisfactory Progress, the student must meet both attendance and academic minimum requirements in both quantitative (academic terms) and qualitative (academic performance).

### **Graduation Requirements**

Classic class students will have be required to apply 20-40 lashes per eye within 3 hours on the 2nd day of class. They must be correctly applied with no visible glue clumps, have proper isolation and attached at the base correctly. Proper preparation and sanitation will also checked to make sure it is done correctly. Styling and suitable lash choice for clients lash. If the student does not pass the practical exam satisfactory, they can come back & re-test until they pass.

Volume class students will be required to successfully cover 50% of the lashes within 3 hours on the 2nd day of the class. They must be correctly applied with no visible glue clumps, have proper isolation and attached at the base correctly. Proper preparation and sanitation will be checked. Styling and suitable lash choice for clients lash. If the student does not pass the practical exam satisfactory, they can come back & re-test until they pass.

For Online certification:Case Studies (2) Before & After Photos of the case studies, close up, no filter, good lighting.(4 per case study. 1 before - from above. 3 after - 1 from above, 1 front facing, 1 side view)\*A short video of you...Classic...Placing at least 20 synthetic eyelash extensions and attaching them to a lash strip on a mannequin or live model. Volume...making at least 10 3D fans and attaching it to a sponge, lash strip on a mannequin or live model.

\*Your Classic & Volume Sets must show in your before and after photos at least 50% coverage of the natural lashes.\*For both Classic and Volume, you must demonstrate good isolation and bonding skills and show an ability to place lashes and fans the appropriate length away from the eyelid.\*Proper length transitioning is important.\*Pass an open book test using the Academy of Advanced Beauty training manuals

### **Conduct Policy**

A student also may be withdrawn from classes if he or she does not prepare sufficiently, neglects assignments, or makes unsatisfactory progress. The director, after consultation with all parties involved, makes the final decision. The Director may temporarily suspend students whose conduct is disruptive or unacceptable to the academic setting. After appropriate counseling, students who demonstrate a genuine desire to learn and conform to school standards of conduct, may be allowed to resume attendance. The director will review each case and decide upon re-admittance. Re-entry fee shall apply. (Page 9)

### **Facilities**

The school is located at 6535 S Dayton St. Suite 2700 Greenwood Village CO 80111. Our training facility is 1600 square feet and is modernly furnished. We have reclining facial beds and utility tables with esthetician stools. Reception area and waiting room with chairs and bench for clients and patrons. Makeup vanity, stool, and utility cart. Coffee/Tea bar. Kitchenette. Restroom is located in the facility. Charts, diagrams and educational videos to enhance classroom learning are available. Ample parking provided and several restaurants in the area for lunch needs.

### **Previous Credits**

The Academy of Advanced Beauty does not accept transfer credits from other institutions and does not guarantee transferability of our credits to another institution unless there is a written agreement with another institution.

### **Student Grievance Procedure**

It is our goal to provide an environment that is peaceful and stress free. We will make every effort to resolve any complaints that are not frivolous or without merit. Student and Guardian complaints may be brought to the attention of the Division of Private Occupational Schools online at http://highered.colorado.gov/dpos, 303-862-3001. There is a two-year statute of limitations for the Division to take action on a student complaint (from student's last day of attendance).

### **Refund Policy**

Students not accepted to the school are entitled to all moneys paid. Students who cancel this contract by notifying the school within three (3) business days are entitled to a full refund of all tuition and fees paid. Students, who withdraw after three (3) business days, but before commencement of classes, are entitled to a full refund of all tuition and fees paid except the maximum cancellation charge of \$150.00 or 25% of the contract price, whichever is less. In the case of students withdrawing after commencement of classes, the school will retain a cancellation charge plus a percentage of tuition and fees, which is based on the percentage of contact hours attended, as described in the table below. The refund is based on the official date of termination or withdrawal.

- 1. The student may cancel this contract at any time prior to midnight of the third business day after signing this contract.
- 2. All refunds will be made within 30 days from the date of termination. The official date of termination or withdrawal of a student shall be determined in the following manner:
  - a. The date on which the school receives written notice of the student's intention to discontinue the training program; or
  - b. The date on which the student violates published school policy, which provides for termination.
  - c. Should a student fail to return from an excused leave of absence, the effective date of termination for a student on an extended leave of absence or a leave of absence is the earlier of the date the school determines the student is not returning or the day following the expected return date.
- 3. The student will receive a full refund of tuition and fees paid if the school discontinues a Program/Stand Alone course within a period of time a student could have reasonably completed it, except that this provision shall not apply in the event the school ceases operation.
- 4. The policy for granting credit for previous training shall not impact the refund policy.

### Academy Of Advanced Beauty Transcript/Diploma/Certificate Financial Hold Exemption Policy

Date Adopted: September 26th, 2024 Date Revised:

### A. Purpose

This policy is in response to Colorado HB22-1049.

### **B. Scope**

This policy applies to all current and former students, excluding foreign students as defined in C.R.S. 23-1-113.5., who have an outstanding debt for tuition, room and board, or other financial aid funds owed to the school and request a transcript, diploma, or certificate. This policy also describes when a student may be subject to a registration hold.

### C. Policy

- 1. Individuals may be subject to a transcript, diploma, or certificate hold when such individual owes certain debts to the School for tuition, room and board fees, or financial aid funds. Individuals will be subject to such a hold when their balance remains unpaid for forty-five (45) days. Their balance must be Zero (\$0.00) before any certificate, diploma or transcript will be released. If it is not paid in full the account will be turned over to a third party agency for collection. If the student would like to arrange a payment plan to resolve the balance they can do so prior to the forty-five (45) day deadline. See section 5 for information. If an individual is subject to such a hold, their transcripts, diplomas, or certificates will not be released unless an exemption applies as outlined in section 2 of this policy.
- 2. Exemptions are granted for individuals who can demonstrate that the transcript/ diploma/certificate request is required for one of the following reasons:
  - a. Job application
  - b. Transferring to another postsecondary institution
  - c. Applying for state, federal, or institutional financial aid
  - d. Pursuit of opportunities in the military or national guard
  - e. Pursuit of other postsecondary opportunities
- 3. Process and Procedure for Exemptions: Upon submission of a transcript/diploma/ certificate request and documentation to verify an exemption, the School will review the request and make a determination regarding whether or not an exemption exists, as outlined in section 2, above. If it is determined that the individual

has a valid exemption, the School will release the requested transcript/diploma/ certificate. If the School determines that the individual does not meet the exemption criteria, the School will provide a written explanation of the denial of the request within seven business days.

- Registration Holds: Individuals will no longer be able to register or enroll for courses/classes if they have an outstanding balance that exceeds \$500.00 for forty-five (45) or more. At which time their account will be turned over to a third party agency for collection.
